## **EPS Strips**

EPS (Expanded PolyStyrene) strips, in virgin or regenerated material, available in various densities, shapes and sizes.

Resistant to mechanical stress, EPS is versatile, durable over the time, hygienic and non-toxic. Furthermore it is an excellent insulator and 100% recyclable.

EPS strips are used to lay down insulating panels so that, once packed and stored, they are not placed in direct contact with the ground.

The use of EPS strips also allows to stack more pack of insulating panels, preserving their integrity and protecting them from any damage during handling phases.




## **Handling Protections**

Low thickness protective «sheets» in EPS, MDF or Foam (expanded polyethylene) realized with a high percentage of recycled material. They can be customized in thickness and size, according to customer needs.

They are placed between the panels and the EPS strips, to better preserve the integrity of the panels during stacking and handling with the forklift.

In some cases they are also placed above the stack of panels to provide protection to packaged products when 2 or more packages are stacked on top of each other.

## Stretch Film for Orbital Machines

Automatic stretch films from 10my to 30my and with a pre-stretch from 150% to 300%.

Made of a multi-layered co-extruded material (LLDPE) with virgin raw materials, in full compliance with the UNI-EN 13427 standard on recyclability and energy recovering.

Possible addition of anti-UV additives 6/12 months, according to needs.

Available in rolls of 500mm per 18kg, in different colours, such as transparent, white opaque, black and blue colour, or on demand with a minimum required production quantity.

Customizable with the application of the company logo with a minimum required production quantity.

## Cover Cap

Cover caps from 40my to 200my, made of multi-layer co-extruded material (HDPE), with virgin or regenerated raw material (in a percentage between 40% and 70%).

Possibility of adding anti-UV additives 6-12 months, according to needs.

Available in various heights and colours (transparent, white opaque, black or blue for the virgin material and amber-white for the regenerated pallet cover cap) or on demand with a minimum required production quantity.

Customizable with the application of the company logo with a minimum required production quantity.




